A LOCAL LAW, INTRO NO. 3\_\_ TO AMEND  
LOCAL LAW NO. 1 OF 2008, SECTION XXII  
188, OFFICIAL NEWSPAPER, OF THE CHARTER  
OF THE CITY OF NEW ROCHELLE.

BE IT ENACTED by the City of New Rochelle as follows:

Section 1. Section XXII 188, Official Newspaper, of the Charter of the City of New Rochelle is hereby amended as follows:

§ XXII 188. Official newspaper.

On or before the 15th day of January in each year the City Manager shall designate as the official newspaper[s] a daily newspaper [and a weekly newspaper] which [have] has been continually circulated in the English language in the City of New Rochelle for at least two years prior to such designation. The City Manager may, however, at his or her discretion authorize special advertising in other newspapers. Any and all requirements in this Charter for publication of official notices in the official newspaper shall be deemed to require publication in [either] the daily [or weekly] official newspaper designated in accordance with this section. The City Manager may direct publication of official notices in both the daily and weekly official newspapers, where appropriate.
